Safety

Health Care Organisations

Core

- ◆ Protect patients
- ◆ Protect Children
- ◆ Follow NICE guidelines
- ◆ Keep patients, staff and visitors safe

Developmental

- ◆ Continuously/systematically review and improve activities that affect patient safety

Clinical and Cost Effective Health care Organisations

Core

Developmental

- ◆ Conform to NICE technology appraisals, clinicians; update skills and take part in clinical audit
- ◆ Co-operate with each other

- ◆ Patients receive effective treatment and care

Governance

Health Care Organisations

Core

- ◆ Apply the principles of sound clinical and corporate governance
- ◆ Support their staff
- ◆ Systematic/planned approach to records management
- ◆ Undertake employment checks
- ◆ Recruit and train staff appropriately

Developmental

- ◆ Integrated governance arrangements
- ◆ Work together to improve quality
- ◆ Work with social care to meet health needs of the population
- ◆ Effective integrated info technology and systems
- ◆ Adopt best practice HR management

Patient Focus Health Organisations

Core

- ◆ Systems in place to: respect confidentiality, privacy and dignity
- ◆ Deal with complaints
- ◆ Provide a choice and balanced diet
- ◆ Information on services

Developmental

- ◆ Continually improve patient experience
- ◆ Receive timely and suitable info on treatment, care and services
- ◆ Help service users to contribute to planning their care

Accessible and Responsive Care

Core

- ◆ Views of patient/others taken into account in designing services
- ◆ All members of the population access services equally
- ◆ Prompt access for patients with emergency needs

Developmental

- ◆ Plan and deliver health care to reflect needs of the population and maximise choice

Care Environment and Amenities

Core

- ◆ Services are provided in environments which:
- ◆ Promote effective care and optimise health outcomes
- ◆ Well maintained and clean

Developmental

- ◆ Environments promote patient and staff well being

Public Health

Core

- ◆ Work in collaboration to promote, protect and improve health of the population
- ◆ Systematic/managed disease prevention/health promotion programmes
- ◆ Planned response to emergencies/incidents

Developmental

- ◆ Act on significant health problems and inequalities
